Tiffanie Marie Dixon Memorial Scholarship - Overview

Zeta Phi Beta Sorority, Incorporated, Phi Gamma Zeta Chapter will award a **\$1,000** scholarship to a female residing in Hopewell and entering a United States college or university in the summer or fall of 2024. The scholarship recognizes academic distinction as well as strong character and personal qualities.

Eligibility Criteria/ Applicant must:

- _____ Be a current female residing in Hopewell, VA.
- _____ Be anticipating completion of a high school diploma in the spring of 2024 or have completed a GED.
- _____ Have a minimum cumulative GPA of 2.75 or score at least a 580 on the GED Exam.
- _____ Have demonstrated leadership abilities through participation in at least twenty (20) hours of community service and extracurricular activities.
- _____ Be entering into a United States college or university in the summer or fall of 2024.

Please submit in one envelope:

- _____ The completed application.
- _____ An official copy of your high school transcript or GED score.
- _____ Letter(s) of documentation for at least twenty (20) community service hours.
- _____ A copy of your acceptance letter to a US college or university.
- _____ Three (3) professional letters of recommendation.
- _____ An original essay of at least 250 words highlighting the life and career of a notable African American female or member of Zeta Phi Beta Sorority, Incorporated and the impact she made/makes on your life.

Selection Criteria

Applicant will be selected based on her academic accomplishments, intellectual and creative distinctions, extracurricular and community service activities, letters of recommendations, and essay. Please, see attached Scholarship Scoring Rubric.

Note: Proof of enrollment is required prior to receipt of the monetary award.
